3. ALL CHEQUES TO BE MADE PAYABLE TO STEAMFEST.
4. ALL POWER LEADS MUST BE TESTED AND TAGGED. THIS IS YOUR RESPONSIBILITY. CORDS WILL BE INSPECTED.
5. ALL BOOKINGS WITH PAYMENT TO BE RECEIVED AT THE ADDRESS ABOVE BY MARCH 1st 2012.
6. THE MANAGEMENT COMMITTEE RESERVES THE RIGHT TO REFUSE AN APPLICATION FOR A STALL. PREFERENCE
WILL BE GIVEN TO STALL HOLDERS COMMITTED TO COMING FOR THE FULL 3 DAYS.
7. **OUR INSURER HAS ADVISED THAT ANY FOOD STALLS AND RIDES MUST PROVIDE US WITH A CERTIFICATE
OF CURRENCY FOR THEIR PUBLIC LIABILITY POLICY FOR \$5,000,000 WITH REDWATER CREEK STEAM &
HERITAGE SOC. INC. LISTED EITHER AS A NAMED INSURED OR INTERESTED PARTY. OTHER SITE HOLDERS ARE
REQUESTED TO PROVIDE A COPY OF THEIR PUBLIC LIABILITY BUT IT IS NOT MANDATORY FOR THEM TO DO SO.**
